- SAFTEA, a Community of Eurasians by whatever named called ,be it Serani, Kristang or simply Eurasians is a unique community that embraces almost every race that lives in Malaysia and we are proud to state that we are truly Malaysians who live in peace and harmony.
- Information on how to enter the Contest form part of the Terms and Conditions of entry. Entry into this Contest deems acceptance of these Terms and Conditions.

- Format of logo design must be in High Resolution and are to be submitted either in Adobe Illustrator, Photoshop or PDF.
- 4. Entrants who submit an Entry must complete all of their details on the form prior to submitting their design including name, age (if under 18 entry forms are required to be submitted by legal guardian), copy of their/legal guardian's NRIC/birth certificate email address, phone number. Incomprehensible, illegible, and incomplete Entries will be deemed invalid. The Judges' decision is final and conclusive.
- Entrants may submit as many Entries as they wish but each Entry must be a different logo design.
- All submissions must be entirely the original work of the Entrant and must not have been previously published or exhibited.
- All submissions deemed copied or not an original work of the Entrant, will not be judged. The Judges' decision is final and conclusive.

# **Judging Criteria**

- The Entry needs to be adaptable to a circle format and must carry the words "SAFTEA 100 Years".
- The theme "CELEBRATING DIVERSITY IN UNITY" should inspire the logo design but need not be written in text nor included within the design itself.
- As SAFTEA is a community-based not-for-profit association, catered to descendants
  of the different European and Asian lineages and other like minded people,
  the Entry should be as inclusive of the diversity in cultures as much as possible.
- The Judges' decisions are final and conclusive and no correspondence will be entertained.

### Prize

- 1. The Prize is cash of RM1,000 and will be awarded to one (1) winner only.
- The Prize must be taken as stated and is non-transferable or exchangeable for other items.
- Any tax payable as a result of the Prize being awarded or received will be the Prize winner's responsibility.
- 4. The Promoter will award the prize in the form of a cheque payable to the winner's name and takes no responsibility for the loss of the Prize in the event of incorrect or imprecise delivery details provided by the Prize winner, or otherwise.

### Open, Close, Draw and Publish Dates

- The Contest commences Saturday, 31 August 2019 and closes Wednesday, 16 October 2019 at 11:59pm ("Contest Period"). Entries must be received by the Promoter during the Contest Period. Entries received after this time (irrespective of when sent) will not be included in the Contest and the Promoter accepts no responsibility for late, lost or misdirected Entries.
- The winning entry will be determined by the Promoter from a panel of judges. Judges' decision is deemed final.
- 3. The winner will be notified by phone or email by 5 November 2019.
- 4. The Prize must be claimed within 30 days of notification of winning.
- 5. In the event the Prize remains unclaimed within that 30 day period, the Promoter may at its discretion award the Prize to the Entry judged as second. The winner of any unclaimed Prize will be notified by email within two business days of this decision.

### **Ownership of Entries**

- There is no guarantee that the winning entry will be used by the Promoter as submitted. Modifications to the logo design may be required depending on usage format.
- 2. All Entries become the property of the Promoter once submitted.
- By submitting your Entry you are giving SAFTEA permission to share your Entry for marketing purposes in social media and any other forms of advertising materials.
- No entrant has any right to compensation or payment for the ongoing use of that Entry by the Promoter.
- 5. In the event that a winning entry is discovered to be not an original creation or had been submitted before to other third parties whether as design in a competition or to a paid client/customer who had purchased or owns the design or for or any other reason whatsoever (e.g. plagarism, not original work, etc.), the prize winner will be disqualified and be liable to return the prize money and shall indemnify SAFTEA against all claims, actions and damages arising.
- To the extent of any inconsistency between these Terms and Conditions and any other reference to this Contest, these Terms and Conditions prevail.
- 7. Except for any liability that cannot be excluded by law, the Promoter and its related entities, employees, contractors, servants or agents shall not be liable for and accept no responsibility for any accident, loss, injury or damage to any individual or property arising out of any act or omission, whether negligent or otherwise in conjunction with the Contest or a Prize, occurring either during or after the Contest.
